2. THE CHAIRMAN'S OPENING REMARKS

The Chair welcomed everyone to the meeting

3. ACCEPT AND SIGN THE MINUTES

The minutes of the Parish Council meeting held on the 27th July 2017 having been previously circulated were approved. Cllr Buxton proposed that they be accepted as a true record, this was seconded by Cllr Prosser and all agreed.

4. TO RECEIVE DECLARATIONS OF INTEREST

5. MEETING SUSPENDED FOR PUBLIC PARTICIPATION

The PCSO said the registrations of the suspicious vehicles that were seen in Weeting have been circulated to other Police forces in the area, the chair said that there had been a number of suspicious vehicles in the village and also foragers had been seen in the forest. The Speed Watch co-ordinator said that Cllr Prosser had been accepted as a volunteer for the scheme subject to training, the volunteers have been threatened by a driver who came back to them whilst they were carrying out a speed check and told them he would run them down, he reported the incident to the police, he said Mr Parrott has now cut down the trees that were overhanging the speed limit signs. The Chair asked the Speed Watch co-ordinator to give him some statistics of the number of cars that are speeding as he would like to present that to Highways to back the Councils application to try and can get a 30mph speed limit starting at Fengate Drove and going through the village. Cllr smith said that he has seen a speeding car that was almost airborne and he will try and get the registration number if it happens again. A member of the public congratulated the Parish Council on the excellent condition of the play area and equipment.

6. MATTERS ARISING

6.1 Outstanding Highway Matters – to discuss any outstanding issues

New speed limit – The Chair asked County Councillor Eagle for his support for the proposed new speed limit through the village. Cars are parking on the pavements in the new estate and it was agreed that the Clerk will ask David Jacklin from Highways to come to Weeting to discuss this and other outstanding matters. Parrotts Piece parking – the Chair said that the parking on the verge cannot be stopped and he is going to contact Highways to discuss putting a mesh over the grass to try and stop any deterioration to the grass. Overgrown bushes in the Pathway to Castle Close – it was agreed that the Handyman trims these back as he has done in previous years. Cllr Lister said she has had complaints regarding trees that are too high in the gardens in All Saints.

6.2 Street Lighting – Street Lighting officers report

Cllr Lister said that there 4 reported out in Angerstein and one in Shadwell. As it will cost £700 to decommission the light in Castle Close and it was agreed not to go ahead with this at this time.

6.3 Playing Field/Open Spaces

Cllr Lister said that the suppliers of the Air Walker are coming out to take a look at it as there is some deterioration on one of the handles causing it to click.

6.4 Slow Down in Our Village Stickers for Rubbish Bins update regarding grant

The Clerk had been informed by County Cllr Fabian Eagle that once she has ordered the stickers and paid for them she is to invoice Norfolk County Council and he will pass this on to the correct department. The Clerk confirmed that they will have standard "Please Slow Down in Our Village" wording on them and she will order 150 stickers.

The Handyman reported that he had cut back the nettles and bushes on the dog walk, fitted concrete repair spur on small gate post on the dog walk, fixed stumps on 3 other 4"x4" post, although it is the School holidays it has been fairly quite regarding the litter picking on the playing field and play areas, the litter bins are being used more and more as well as the dog bin, took 2 wheelie bins back to Mr Colin Parrott who had kindly loaned them to the WPC for their Fete Days, Mr John McAndrew kindly litter picked the playing field and play area whilst the Handyman was on holiday and it was agreed that the Parish Council write a letter of thanks to both Mr Parrott and Mr McAndrew for their help, there is still some household waste being left at the bottle bank including carrier bags containing nappies, still putting clothes into the clothes bank, however the cloths bank is being emptied at more regular intervals.

7.4 Bowls Club Report

Cllr Lister said they now have extra players and are doing very well and they hope to start the refurbishing work on the WC's in October. Cllr Prosser said they have been looking at new ride on mowers, Cllr Lister said that they picked some equipment up from Thetford yesterday that included 2 lawn mowers and some tables and chairs. Cllr Prosser said that Goff are sponsoring their shirts and tomorrow they are having a photo shoot when they will be formerly presented with the shirts from a chief executive from the company.
