#### 5.1 District Councillors Report – Cllr R Kybird

There is a grant fund for £500

#### 5.2 County Councillors Report – Cllr F Eagle

The missing link for the Western Link has now been signed off for Government approval. NCC have got a 46 million budget gap to fill.

NCC have received a large bit of government funding to launch "Working Well" which is a scheme to help get people back to work.

If funding is available, the Norfolk Records Office is looking to arranging an exhibition on Norfolk's Lost Houses.

- a) Installation of trod between Lynn Lodge and Cromwell Road update on quote from Highways still outstanding, this has been chased again. Darren Warmsley is the new area manager so the Clerk will take this up with him direct and copy in Cllr F. Eagle
- b) Carvery Sign obstructing drivers vision onto Lynn Road update following email from Highways saying they would remove the sign if necessary, still outstanding Highways have been chased again
- c) Overhanging trees/shrubs on junction Peppers High Hill and Mundford Rd from Brick Kiln Farm- letter has now been sent to Brick Kiln Farm, and following letter sent to Mill Farm they have said they will cut back the trees asap the Chair Thanked Cllr Ian Childerhouse for cutting back the hedges on the Mundford Road.
- d) Dangerous trees Fengate Drove The Clerk has sent a letter to the resident asking that he contact Highways direct and informing him that the Parish Council are unable to intervene with this matter.
- e) Highways Slow Down Signs response from National Highways National Highways told the Clerk to contact Norfolk Highways, an email has been sent to them. Cllr Eagle will also look in to this

- b) Swift Tower price for a small Swift Tower is £1950, County Cllr Eagle said he will reimburse this PC for the cost of this, The Clerk will order the tower.
- c) Grass Cutting areas Wil Smith-TTSR update on quote for the extra areas they have been chased up again and we have been told they will get back to us.
- d) Orchard Plaque Clerk has emailed Breckland to ask where they purchase their plaques from, but has had not response. It was agreed that the Clerk will get a price from the local engraver in Brandon and the following wording would be put on the plaque -

"Heritage Orchard. Planted by Weeting Parish council in 2022 to commemorate Queen Elizabeth II 70 year reign"

e) Captain Toms Memorial plaque – The wording for the plaque has been sent through from the school

"Captain Tom's Memorial Garden Inspired by the children of Weeting Primary School during Lockdown 2020"

A price for this will be obtained from a local engraver in Brandon.

- f) Open top bin on Play Area update on removal TJM said they will remove this at no charge.
- g) Picnic bench by the teen shelter following Rospa's report Cllr Lister has asked for a price to remove concrete base around the bench which is a trip hazard, TJM to come back with price.
- h) Vandalism on the old telephone box that housed the defibrillator reported to the police and has been repaired, CCTV can be considered for this area.
- i) Elm Trees cut back on the dog walk without PC's permission letters have been sent to the residents in the area asking that the seek permission before cutting back trees on land that belongs to the PC.
