5. MEETING SUSPENDED FOR PUBLIC PARTICIPATION

A member of the public spoke regarding Hereward Way – problem with vehicles that are parked in the road that are being worked on by the garage and also speeding in the road, he read out the correspondence that he has sent to Simon Taylor Avery of Breckland Council and also to District Cllr Sam Chapman Allen and also their replies, the conclusion to this is that Breckland Council are to send a formal letter to the garage. A member of the public said that Mr Malcolm Fuller of Style Windows had complained to him about the rubbish and debris on the side of the road at Emily's Wood bungalow on the A1065 and it was agreed that the Clerk will write to Mr Fuller to inform him that action is being taken by the local authorities and social services. A member from the church said that they are very grateful for the help that they receive financially for the church from the Parish Council.

9.2 Parish Council Insurance – to agree a new favourable quote from Zurich

The Clerk said that the Parish Council are currently paying Came and Country £1786 a year for a 3-year contract that finishes this year. Zurich have quoted like for like for 3 years at £1540 saving £738 over 3 years. Following a discussion, it was agreed that the Parish Council will switch their insurance to Zurich this was proposed by Cllr Buxton, seconded by Cllr Burlingham and all agreed.

9.3 End of Service Gratuities for Parish Council Employees

The Clerk had enquired with a lawyer from SLCC on the laws regarding Gratuity payment for Parish Council employees and she has received the following reply "You refer to a 'gratuity', but are you

talking about a formal gratuity as per the Local Government Superannuation (Discretionary Payments) Regulations 1996 or are you using the word 'gratuity' as meaning a lump sum of some sort upon retirement?

If the former, that scheme has ceased but payment may still be made providing it had been promised to the employee (by way of their Contract of Employment) and provision made for it in your budgeting. That scheme can be paid free of tax.

You could alternatively, decide to simply give your employee a sum of money on his retirement, but this would be subject to tax and NI just as is the rest of his pay. How much you pay rather depends upon the length of service, earnings, how well you feel they did the job and, perhaps most of all, what sum you think might be acceptable to the electorate!" The Clerk said that she would confirm this in writing to Mr Reay.

- **9.4** Grant application from Weeting Open Gardens for money towards programmes Following a discussion, it was agreed that the Parish Council would not donate towards this as they already pay £1,400 a year for the Churchyard grass cutting.
